### MELBA S. LEHNER CHILDREN'S SCHOOL --- WEBER STATE UNIVERSITY PRE-SCHOOL EXTENDED HOURS – COMMUNITY EDUCATION CENTER

The Weber State University Extended Hours Community Preschool is operated within the Melba S. Lehner Children's School classroom located in the WSU Community Education Center on 26<sup>th</sup> and Monroe.

The Extended Hours Preschool accommodates approximately 20 children from the Ogden community. **Children must be three years old by September 1**<sup>st</sup> in order to attend during that school year. Children who attend kindergarten or higher grades are not eligible for this program. Applications are taken throughout the school year and will be considered on a first come first served basis. Priority is given to children of students enrolled in CEC, income eligible Ogden City families, WSU students, and then WSU faculty and staff. **HOURS:** The Extended Hours Preschool opens at **7:30 A.M.** and closes at **5:00 P.M.** The center follows the University calendar with extended weeks in December and May and will be closed holidays, the first day of each semester, semester breaks and summer semester.

**FEES:** Low-cost tuition based on household income. A minimum participation of 30 hours per week is required. Tuition is a standard of \$137.00 a week. See below for low-cost tuition sliding scale to adjust rate for qualification.
